RETHINKING THE HUMAN DIGNITY AND NATION IDENTITY (A REVIEW PERSPECTIVE OF ARTS AND ARTS EDUCATION): AN INTRODUCTION

ne of the big burdens of the current contemporary civilization is the big narration of Humanism, particularly in relation to the questions of humanity and nation dignity. Firstly, the human dignity which has been for a long time fought and cared for through various cultural strategies, remains becoming the main concern. The Humanism idea which takes the Anthropomorphism as its main basis, as the result of the European Enlightenment that nowadays remains respected as defending human dignity, in fact really cannot explain that condition. Humanism, currently has been seen as the main opponent of humanity. This is the result of its universal sublimation that it turns to be the Metaphysics Humanity, that is beyond everything. The nature of human identity and humanity which is plural-particular in the Universal Classical Humanism, has often been treated to be singular-universal. Through this context, the nature of humanity differences is not merely considered as 'the other' (Sang Liyan), but even as a taboo which needs to be eliminated as it is considered as subhuman. It is from this point of view that finally the practices of humanity colonization for the sake of uniformity, through various means, either the one which is hegemonicpersuasive or that of coercive, seems to find their true contexts in culture.

Secondly, the question of nationality which has similar discourse to that of humanity problem mentioned earlier. This is due to the fact that the main part of the nationality dictum is also about the domain of humanity identities, particularly, when this domain appears in the contexts of collective imaginative construction of understanding. In addition, one of the great problems of the nationality discourse, particularly, the one had by the Third World countries is relatively the same, that is, related to the question of the nature of self dignity that needs to be constructed and owned. Similar to the imaginative Humanism, the nature of modern civilization has been under hegemony or even being colonized by Positivism tradition that puts the standard imagination of 'normality' of knowledge not to mention nationality owned by all nations in the world, in a uniformity. The nations which are different in nature or which always struggle to be different from others, immediately, considered as the elements of 'the other' (sang liyan) that must be defeated. This phenomenon merely portrays the colonization practice in the postcolonial era.

Therefore, the nature of humanity, nationality, and also Arts and Culture, which is actually a unity of particular elements in the universality, then tends to miss its articulation space and respect due to the desire and uniformity politics. This mainstream of modern culture strategy seems to be a kind of serious problem that needs to be significantly taken care of, either in the context of culture in its wider sense or in the domain of Arts and Arts Education as its limited domain. One of the inherent basic values of Arts and Arts Education that is the spirit of respecting authenticity and particularity seems to be considered as a significant review.

Starting from this idea, then, the three Arts Departments of Arts Education (Visual Arts, Dance, and Music) worked collaboratively to conduct this conference at Faculty of Languages and Arts, Yogyakarta State University. Thanks to Allah that this conference has a remarkable response from other disciplines, namely, Theater, Letters and Language that are under the same heading of Humanity Sciences. Being one of the various events in commemorating the golden anniversary of Yogyakarta State University (Dies Emas UNY) in this year, 2014, hopefully it could bring a golden light of Arts that enlighten the nation identity and later give a valuable light to the coming world civilization.

As the head of the committee, I would like to express my sincere apology, if we cannot give the best service for all of the participants. In this particular occasion, it is important to mention that for some reasons finally the committee comes to the decision to present this proceeding in two languages, English and Indonesian, with the hope that it will not lessen the significance of this international conference.

MEMBUDAYAKAN KRITIK SENI DI TENGAH MASYARAKAT DAN SENIMAN

Abstrak

ritik seni di dalam suatu penciptaan karya seni sangatlah penting untuk dihadirkan. Bukan saja sebagai jembatan antara seniman pencipta dan masyarakat umum, untuk mengetahui kelebihan dan kekurangan yang ada dalam seni ciptaan tersebut, tetapi juga sebagai penghargaan terhadap karya yang telah diciptakannya. Bagaimana rasanya sang pencipta karya seni yang telah berusaha menuangkan segala kemampuan yang dimilikinya untuk mencipta karya seni, tetapi setelah karya tersebut jadi dan disajikan di hadapan masyarakat tidak ada tanggapan dari orang lain, untuk merespon karyanya tersebut. Lebih-lebih bagi karya seni pertunjukan yang hanya sesaat saja disajikan.

Respon atau tanggapan dari kritikus (orang yang melakukan kritik) inilah yang sering disebut dengan kritik seni. Kritik seni bisa diungkapkan secara lisan dan langsung, bisa pula ditulis di media massa. Oleh sebab itu kritik seni bisa dibedakan menjadi: Kritik Pra-Predikatif, Kritik dengan Kata-kata, dan Kritik Ilmiah

Tanggapan dari sang pencipta karya seni (seniman) dengan adanya kritik seni yang ditujukan untuk karyanya, ada yang menanggapi dengan senang, kurang senang, tidak senang atau biasa-biasa saja.

Pengantar

Istilah kritik atau critism (Inggris) berasal dari bahasa Yunani yakni kritikos yang berhubungan dengan krinein yang berarti memisahkan, mengamati, membandingkan dan menimbang. Arti kata kritik adalah suatu cara atau metode untuk membahas, menimbang, mengamati, membandingkan, memilah-milah (menyeleksi), mengulas, mengurai, menafsir, meninjau, komentar, menelaah, menilai, mengevaluasi dan mengkaji. Kritik seni adalah mengamati, membahas dan mengulas karya seni, baik seni pertunjukan (tari, musik, teater,

- didasarkan pada alasan ilmiah, tetapi lebih di dasarkan pada ketidakpuasan.
- 3. Kritik ilmiah, yaitu kritik yang dilontarkan baik berbentuk kata-kata ataupun tulisan yang dilandasi oleh suatu ilmu. Pada fase inilah ulasan yang sebaiknya kita pergunakan untuk memberikan kritik terhadap suatu kajian seni pertunjukan, karena untuk mengutarakan kritikan tersebut di dasarkan pada tiga aturan. Yaitu Logika, Etik dan Teknik. Logika adalah kritik atas pemikiran, Etik adalah kritik atas perbuatan susila, dan Teknik adalah kritik ilmiah atas praxis manusia. Dalam posisi seperti tersebut, dikatakan kritik ilmiah dapat dianggap sebagai kritik yang berada pada tingkatan yang lebih tinggi (1975: 31).

Kritik adalah suatu penilaian atas nilai yang intersubjektif. Dan penjelasannya bukanlah terdapat pada keinginan seseorang saja, jika kita melulu ingin mendasarkan kritik atas keinginan yang timbul pada diri kita sendiri saja, maka kita harus berkesimpulan bahwa kritik itu tidak lain daripada senang atau tidak senang (1975:14)

Simpulan

Alastair Macaulay yang dikutip oleh Sal Murgiyanto mengatakan bahwa, Titik tolak yang paling baik bagi seorang kritikus tari untuk mulai menulis kritik adalah ketidaktahuan (ignorance) dan pengakuan bahwa ia memang "ignorant" (tidak memiliki pengtahuan tentang apa yang ditulisnya). Alat pertama yang diperlukan oleh seorang kritikus bukanlah riset dan pengetahuan, tetapi sensibilitas (kepekaan persepsi) saya senang memiliki banyak informasi, saya senang memperolehnya, saya senang menggunakannya. Akan tetapi, saya juga tahu, sebagaimana setiap peneliti menyadari, bahwa saya tak akan pernah cukup memilikinya. Maka sebagaimana seorang peneliti, saya harus mulai menulis dengan fakta yang tidak lengkap yang ada di tangan saya. (2002: 6). Oleh sebab itu penulis memohon untuk bersama-sama memajukan seni tari yang kita cintai ini dengan menulis 4 halaman kuarto, dan dikirim ke redaksi harian/mingguan.
