Tugas wasit Execution:

1. Menilai teknik Gerak
2. Sinkronisasi Gerak

KRITERIA DAN PEMOTONGAN NILAI

- **TEKNIK**

Kapasitas fisik: gerakan yang sempurna pada saat menampilkan satu tampilan, posisi tubuh sempurna, menampilkan kelentukan pasif dan aktif, kekuatan, power dan daya tahan otot

- **SINKRONISASI** untuk MP/TR/GR (-0.1 setiap waktu)
- *small error each time 0.1*
- *medium error each time 0.2*
- *large error each time 0.3*
- *unacceptable execution or fall each time 0.5*
- **Maximum deduction for an element 0.5 point** **Maximum deduction for Synchronisation for the whole routine 1.0 point**

DIFFICULTY

- Tugas wasit Difficulty
 1. Mencatat semua elemen tingkat kesulitan dengan shorthand symbol
 2. Memberi pemotongan nilai pada elemem yang lebih dari 12
 3. Memberi nilai 0.0-1.0 pada 12 element pertama untuk (MP/TR/GR), dan 10 elemen pertama u/ IM/IW
 4. Mengevaluasi elemen baru yang tidak ada dalam COP
 5. Memberi pemotongan nilai bila terjadi missing group

Lanjutan.....

6. Memberi pemotongan nilai untuk elemen bawah lebih dari 6 u/ MP/TR/GR dan 5 u/ IW/IM
7. Memberi pemotongan nilai untuk elemen jatuh push-up dan jatuhan split lebih dari 2 elemen
8. Dua wasit difficulty diperbolehkan saling berunding dalam penilaian untuk menyamakan persepsi

- ***Deductions:***
- *More than 12 or 10 difficulty elements per additional element 1.0*
- *More than 6 or 5 difficulty elements*
- *on the floor per additional element 1.0*
- *More than 2 difficulty elements*
- *in landing to push up and / or per additional element 1.0*
- *to split position per additional element 1.0*
- *Repetition of an element per element 1.0*
- *Missing element groups per missing group 1.0*

CHAIR OF JUDGES

Deductions, warnings and disqualifications made by the Chair of Judges Panel:

Deductions and declarations of warnings or disqualifications given by the Chair of Judges Panel are made as follows:

- *Time infraction* 0.5
- *Time fault* 1.0
- *Failure to appear on the competition area within 20 seconds* 0.5
- *Presentation fault* 0.5
- *Walk-over* disqualification
- *Themes in contravention of the Olympic Charter And the Code of Ethics* 2.0
- *Missing or more lifts than number allowed (1 – 2 – 3)* each time 0.5
- *A standing lift higher than 2 standing persons each time* 1.0
- *Prohibited lift* each time 1.0
- *Prohibited moves* each time 1.0

Lanjutan.....

- *Interruption of performance each time for 2-10 sec* 0.5
- *Stop of performance score* 0
- *Presence in prohibited area* warning
- *Improper behaviour / manners* warning
- *Incorrect attire (jewellery, ornaments, body glitter, national identity, sequins for men's attire, etc.)* each time 0.2
- *Wrong attire 2.0*
- *National tracksuit not being worn (see T.R 2009 Art.10.4)* warning
- *Competition attire not being worn at medal award ceremony (see TR 2009 Art.10.4)* warning
- *Serious breach of the FIG Statutes, Technical Regulations or Code of Points.* disqualification
